Are there services covered before you meet your deductible ?	In network medical and hospital services are not subject to a deductible.	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. Do you need a referral to see a specialist ?	Yes, A referral is required to see a specialty care provider (SCP).	This plan will pay some or all of the costs to see a specialist for covered services but only if you have a referral before you see the specialist .
